Offerings may be limited by the availability of space, teachers, or Edgenuity course availability.

Instructional Content and Curriculum

Approval to take a course must be completed annually as online course offerings change. Students are expected to complete the Edgenuity course within the session it was started. Students may attempt to recover multiple courses, but one course must be completed before starting the next. Instructional assignments are computer-based and aligned with the New California State Standards.

Students will be released from the Credit Recovery Program upon successful completion of individual remediation plans, or when all course requirements have been met.

TTUSD transcripts will display the original grade of “D” or “F”. Students can remediate a D/F grade, and earn up to a grade of “C” through the completion of an Edgenuity course. The new grade earned will be used for computation of a student’s grade point average. Students may drop the course, and no partial credit will be granted. No partial or “I” incomplete credits can be remediated.

Process

1. Students must complete the registration form and meet with their school counselor.
2. The school counselor will submit the form to the credit recovery coordinator Ms. Kate Teller.
3. Ms. Teller will contact the parent/guardian and/or student to finalize the process.

Students must register for the credit recovery program. The deadline to register for the Summer of 2021 is Wednesday June 16th.
